II. ARE COOKIES USED?

Cookies are small text files that we send to your browser during your visit to our website and store there. As an alternative to using cookies, information can also be stored in your browser's local storage. Some features of our website cannot be offered without the use of cookies or local storage (technically necessary cookies - the site would not function properly without them). Other cookies, on the other hand, allow us to carry out various analyses so that we can, for example, recognise the browser you are using the next time you visit our website and transmit various information to us (non-essential cookies). By using cookies, we can, among other things, make our website more user-friendly and effective for you, for example by tracking your use of our website and determining your preferred settings (e.g. country and language settings). When third parties process information through cookies, they collect information directly from your browser. Cookies will not cause any damage to your end device. They cannot run programs or contain viruses. We provide information about the respective services for which we use cookies in the individual processing procedures. Data is also transferred to third parties outside the European Union and processed there. Detailed information about the cookies used can be found in the cookie settings or in the request for consent to the use of cookies when visiting the website. When you set up your browser, you can decide whether you agree to the use of cookies and similar technologies in general or whether you want to change certain settings on the website. Within the advanced settings, you can provide further information to grant consent for particular purposes or particular functions and withdraw consent at any time for the future by using the icon on the website. It is possible that

if you disable cookies and similar technologies, your browsing experience may be adversely affected and some features may not work as intended.

III. THE DIVISION OF COOKIES AND WHICH COOKIES WE USE:

The cookies used by our website can be grouped according to the period of their activity and the entity that introduced them.

There are cookies that are temporary and whose existence in the browser ends when you exit the browser, while others, called persistent cookies, remain stored for a longer period of time or until they are manually deleted.

Furthermore, cookies can be divided into those that are directly installed by our website and serve to keep it running smoothly, and cookies from external sources, such as social networks or advertising services, which are generated by sites that are not directly our homepage.

Depending on their function and purpose, cookies are usually divided as follows:

● Technical or functional cookies - NECESSARY

These cookies are used to ensure the correct functionality of their sections and to remember your settings. These essential cookies help us to improve your online experience and may be used without your explicit consent. They provide the basic functionality of the site, the site cannot function without them. **To do this we use:**

● Statistical cookies

To improve our website, we also use analytics cookies to provide us with information about how our website is used. This data allows us to make necessary adjustments and improvements. All information obtained from statistical cookies is anonymous. The storage of these cookies requires your approval. **We obtain these cookies through Google Tag Manager, Google Analytics.**

● Marketing/Tracking cookies

Special cookies are used for marketing and tracking purposes, which can create profiles and track users across different sites. These cookies are used for ad targeting and require your consent as they are used for tracking purposes. **We do not use this type of cookie.**

Third party tools from which we obtain individual cookies:

Google Tag Manager

Google Tag Manager is a tool for managing measurement codes on websites. Google Tag Manager collects statistical data on the website and sends it to Google Analytics. Google Tag Manager does not collect any personal data. These cookies only affect the user who has activated the preview and debug mode and do not affect regular website visitors. Importantly, once the user exits preview mode, these cookies are deleted. Google Tag Manager can be used

with consent mode. On the basis of your consent pursuant to Article 6 (1) letter GDPR. You give your consent via your settings for the use of cookies (cookie banner / Consent Manager), through which you can also declare your withdrawal at any time with effect for the future pursuant to Art. 7 (3) GDPR. If you do not give us your consent, it is possible to visit our website without restrictions, but not all functions may be fully available. The specific storage period for the data processed is beyond our control, but is determined by Google Ireland Limited. Google Analytics

We use Google Analytics as a tool that allows us to collect statistical data about web users. V. PROHIBITION OF THE USE OF COOKIES

Your browser allows you to delete cookies automatically or manually and you can set your browser to block certain types of cookies. You can change your browser settings to receive notifications whenever cookies are stored. Your browser Help will tell you how to do this. Please note that deactivating all cookies may lead to impaired website functionality. If you delete the cookies and visit our website again, they will be set again with your consent.

If you wish to delete the cookies stored on your device and configure your web browser to refuse cookies, you can usually do so in the "Options", "Tools" or "Preferences" menu of the browser you use to access our site.

VI. YOU HAVE THE FOLLOWING BASIC RIGHTS IN THE PROTECTION OF YOUR PERSONAL DATA:

- Right to information: it is your right to be informed of the reason for the collection of your personal data, its use and the duration of its retention.

- Right of access: you can request information about the personal data we hold about you at any time.
- Right to modification: You have the right to update, correct or request the removal of your personal information at any time.
- You have the possibility to withdraw your consent to the processing of your personal data at any time and request its deletion.
- Right to data portability: You can request to move all your data to another data controller.

VII. PRESENCE ON SOCIAL MEDIA PLATFORMS
